

Evan Williams Honey #ChillPic Contest

OFFICIAL RULES

NO PURCHASE NECESSARY. PURCHASE WILL NOT IMPROVE CHANCE OF WINNING. VOID IN PUERTO RICO,

U.S. TERRITORIES AND WHERE PROHIBITED. BEGINS 12:00PM ET FEBRUARY 3, 2014; ENDS 12:00PM ET MARCH 3, 2014.

ELIGIBILITY: The Evan Williams Honey Chill Pic Contest (Contest) is open to legal residents of the United States, except residents of Puerto Rico, U.S. Territories and where prohibited, who are 21 years of age or older. Employees, officers and directors of Heaven Hill Distilleries, Inc. (Sponsor), its parent, subsidiaries, retailers, wholesalers, distributors and affiliates, XenoPsi Media, LLC (independent judging firm), GameSafe, Inc. (administrator) (Partners) and their family members, or those living in the same household of each, are not eligible to enter or win.

TO ENTER: If you are a registered Instagram account holder (or agree to create a free Instagram account), you must 'follow' Evan Williams Honey Reserve (@evanwilliamshoney) on Instagram, upload an original photo (through your account) showing what you love about Winter, include the hashtag #ChillPic and post the photo via internet enabled mobile device (mobile device carrier's data charges may apply) between 12:00pm eastern time (ET) February 3, 2014 and 12:00pm ET March 3, 2014 (Promotion Period). Editing or filtering the image is optional. Official Rules are available at www.EvanWilliams.com/ChillPic.

Entries must be posted through a valid Instagram account by 12:00pm ET March 3, 2014, **however, to be considered for all four judging periods** (listed in the **WEEKLY JUDGING PERIODS & NOTIFICATIONS** section below), **entries must be received by 12:00pm ET February 10, 2014.** *Non-winning entries continue to remain eligible for subsequent judging period(s), if any.* You may enter as often as you wish, however each entry must be unique and submitted separately (see additional details in **ENTRY REQUIREMENTS** section below). Should a dispute arise as to the identity of an entrant, the person named as the authorized Instagram account holder used for entry will be deemed the entrant. Should multiple names be listed on the Instagram account, the first name listed will be considered the primary account holder and, therefore, the entrant. *Each entrant is responsible for the content of the photo used to complete the entry process, and continues to own the image(s) submitted. Entrants who are registered account holders with any other social media provider (i.e., Twitter, Pinterest, Facebook, etc.), may choose to share their entry/entries via those channels, however, should you share an entry, regardless of form or method, if the image contains any material that is copyrighted, trademarked or otherwise protected (including images or likenesses of any person or persons, location, venue or product), you remain responsible for the public use of the image(s), including sharing alcohol-related materials with persons under the age of 21. Sharing an entry will not increase an entrant's chance of winning, and neither Evan Williams Honey Reserve nor Heaven Hill will compensate an entrant who chooses to share an entry.*

Instagram's time clock will be the official Contest clock. Entries will not be acknowledged or returned. Any entry submitted outside authorized, legitimate channels, or not in compliance with these Official Rules, will be void. If the same image is submitted by more than one entrant, or by the same entrant multiple times (Duplicate

Entries), only the first entry will be considered valid and all subsequent Duplicate Entries will be void. Sponsor is not responsible for entries that are incomplete, ineligible or misdirected. By entering, entrants agree to be bound by these Official Rules.

ENTRY REQUIREMENTS: Photo used must depict what the entrant loves about Winter, and will be judged on criteria outlined below. If any person(s) appear in any entry photo, they must be 21 years of age or older, and age verification may be required, at Sponsor's discretion, prior to determining eligibility of entrant. If any entry includes a trademarked, copyrighted or protected location, product or image, that entry may still be eligible for judging (at Sponsor's discretion), however, Evan Williams Honey may not be able to use, post or share the image as entered. An image may include photos, illustrations or other graphics, visuals or designs, but must be submitted in photo format as listed below.

Any entry that is not in compliance with these Official Rules or, in the opinion of the Sponsor or judges, was fraudulently created or is incomplete, offensive or deemed inappropriate will be disqualified.

To be considered for judging, entry must adhere to the requirements listed and be complete, including photo (images may be black and white or color and must adhere to Instagram uploading requirements and guidelines) and ChillPic hashtag (#ChillPic).

A panel of pre-qualifying judges, consisting of Sponsor's marketing personnel and/or agency personnel selected by Sponsor, will review each entry submitted to determine whether, in panel's sole discretion, the entry is eligible for judging. Only those entries that are eligible will be judged.

ENTRANT NOTIFICATION AND RELEASE: Entries submitted may be located and viewed by searching the #ChillPic hashtag. Appearance within the #ChillPic page(s) is not a confirmation of eligibility. Entrant is solely responsible for content of entry and is advised to consider copyright, trademark and privacy regulations before submitting any entry.

WEEKLY JUDGING PERIODS & NOTIFICATIONS: The independent judging firm, whose decisions are final and binding in all matters relating to the Contest, will determine Weekly Prize winners, from all eligible entries received as of noon ET on the following Judging Dates: February 10, 2014 (Week 1); February 17, 2014 (Week 2); February 24, 2014 (Week 3); March 3, 2014 (Week 4). Judging firm will attempt to contact potential Weekly Prize winners via comment on the entrant's entry and/or direct message to the entrant's Instagram account within four (4) days [February 14th, 21st, 28th and March 7th] of the applicable Judging Date. Required response must be received by administrator within four (4) days of the date on the notification or prize will be forfeited and an alternate winner will be selected.

PRIZES: Weekly Prize (200: 50 per Judging Date): Winner will receive two (2) Evan Williams Honey Reserve branded shot glass ice molds (2-shot glass-shape).

Approximate Retail Value (ARV) of prize: \$10 each. Limit: Each entrant is limited to winning one Weekly Prize each week during the Contest.

Total ARV of all Prizes: \$2,000.

Sponsor or its agent will comment on and/or direct message each potential Weekly Prize winner entry, asking the entrant to contact the administrator within two (2) days to complete and return a Release. Entrant may also be required to complete and return a License Agreement at Sponsor's discretion. Required documents must be received by

Sponsor's administrator within four (4) days of the date on the notification or prize will be forfeited and an alternate winner will be selected. All prizes will be awarded provided a sufficient number of eligible entries are received, but in no event will more prizes be awarded than are listed in these Official Rules. Unclaimed prizes will not be awarded. Taxes on prize, if any, and any other costs, fees or expenses not specifically listed herein as included are the responsibility of the winner. WEEKLY PRIZE WINNER SELECTION/JUDGING CRITERIA/TIES: Entries meeting eligibility requirements will be judged by a panel of judges made up of Sponsor's marketing team members and individuals from the advertising and/or creative industry, to select the potential Weekly Prize winners. Judging will occur on the following dates (from noon ET on the first day through noon ET on the last day) for each Judging Period:

Judging to select potential Weekly Prize winners will be based on the following criteria: a) photo content with focus on "Winter" theme [50%], b) uniqueness of image [40%] and c) quality of photo [10%].

Each Weekly Winner must complete and return required documents (as described in the **PRIZES** section above) prior to being confirmed as a winner. Ties, if any, will be broken by re-judging only the tied entries until the tie is broken. Decisions of the judges will be final and binding. Sponsor reserves the right to not award all of the Weekly Prizes if there are insufficient qualifying entries.
